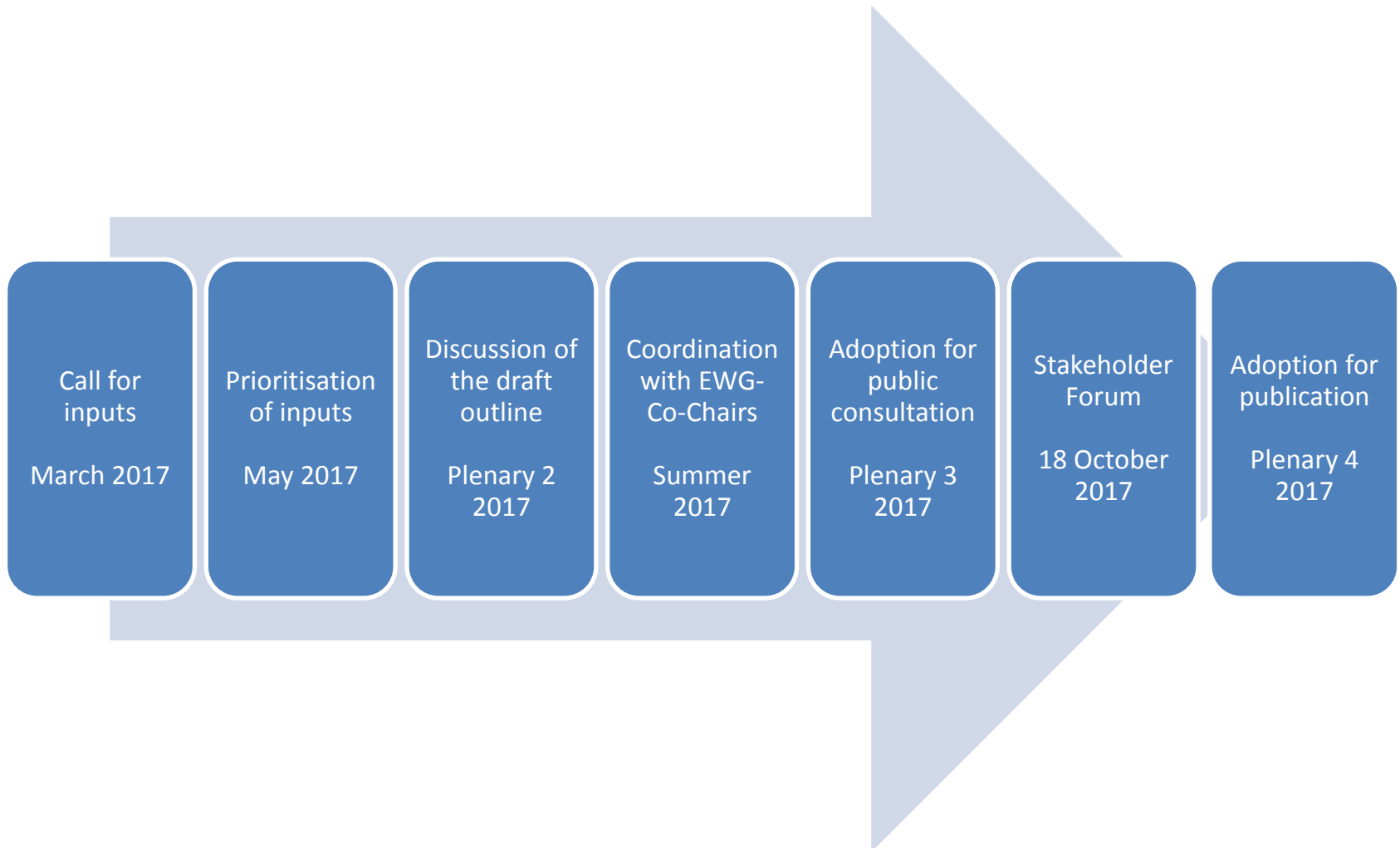

BEREC strongly supports

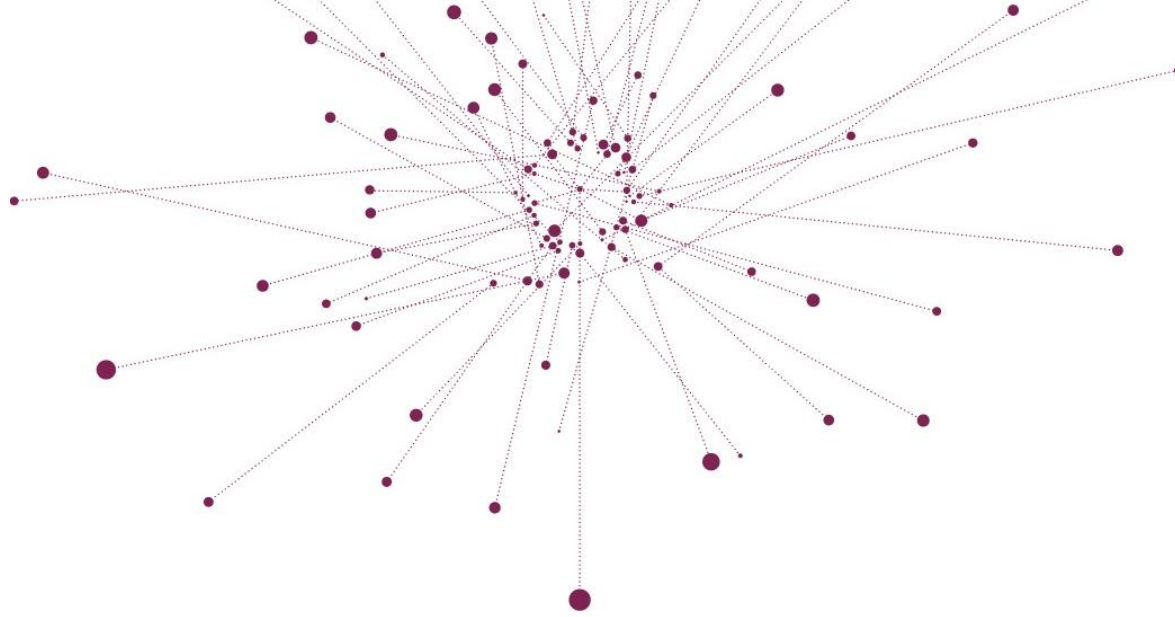
- the connectivity objective and the Gigabit society ambition set by the Commission
